1. Introduction

The year 2025 was marked by continued growth, deepening, and professionalization for Closely by His Side Ministries Foundation. While 2024 was a year of full dedication to the ministry, 2025 focused primarily on expanding activities, strengthening the organization, and preparing for future growth.

The demand for guidance continued to increase significantly. During the year, the waiting list grew substantially, making it increasingly clear that expanding capacity would become necessary.

People from a wide variety of church backgrounds, as well as those without any church affiliation, found their way to the ministry. Many testified of restoration, freedom, healing, and a renewed relationship with God.

2.2 Aftercare and Follow-up Support

A significant step was taken in the professionalization of aftercare during 2025.

The aftercare process was largely automated, enabling participants to receive guidance, encouragement, and follow-up support at fixed intervals for several months after completing their program.

This allowed us to provide better support while reducing the administrative burden on the team.

2.3 Send Me School

In January 2025, the first official edition of the Send Me School was launched.

This training school focuses on equipping believers in the areas of:

- Healing
- Deliverance
- Prophecy
- Identity in Christ
- Practical ministry
- Spiritual growth

The school consisted of ten teaching evenings and attracted approximately forty participants from various church backgrounds.
